

#### **WELFARE FUND REPORT**

Trustee Marty Tew reports for the Health & Welfare Fund for October, 2011, that Income of \$3,660,570.79 plus Investment Income of (\$916,178.33) minus Expenses of \$2,549,016.69 yielded a Net Income of \$195,375.77.

For the Fiscal Year-to-Date, Income of \$19,327,395.22 plus Investment Income of (\$2,550,186.24) minus Expenses of \$17,069,879.48 have yielded a Net Income of (\$292,670.50).

The Fund Value as of 10/31/11 was \$94.358.469.44.

#### **PENSION FUND REPORT**

Trustee Miles Beatty reports for the Pension Fund for October, 2011, that Ordinary Income of \$3,427,736.42 plus Investment Income of \$10,432,344.35 minus Expenses of \$3,255,432.79 yielded a Total Net Income of \$10,604,647.98.

For the Fiscal Year-to-Date, Income of \$20,144,593.89 plus Investment Income of (\$19,281,738.22) minus Expenses of \$22,538,047.39 have yielded a Net Income of (\$21,675,191.72).

The Fund Value as of 10/31/11 was \$521,373,912.32.


### LOOKING BACK & LOOKING FORWARD

Financial reports from the JATC Committee for October, 2011, indicate that Ordinary Income of \$184,550.34 plus Investment Income of \$88,217.90 minus Expenses of \$153,967.51 have yielded a Net Income of \$118.800.73.

For the Fiscal Year-to-Date, Ordinary Income of \$1,412,067.87 Investment Income of \$172,073.74 minus Expenses of \$1,497,461.54 have yielded a Net Income of \$86,680.07. The Fund Value as of 10/31/11 was \$4,798,648.47.
